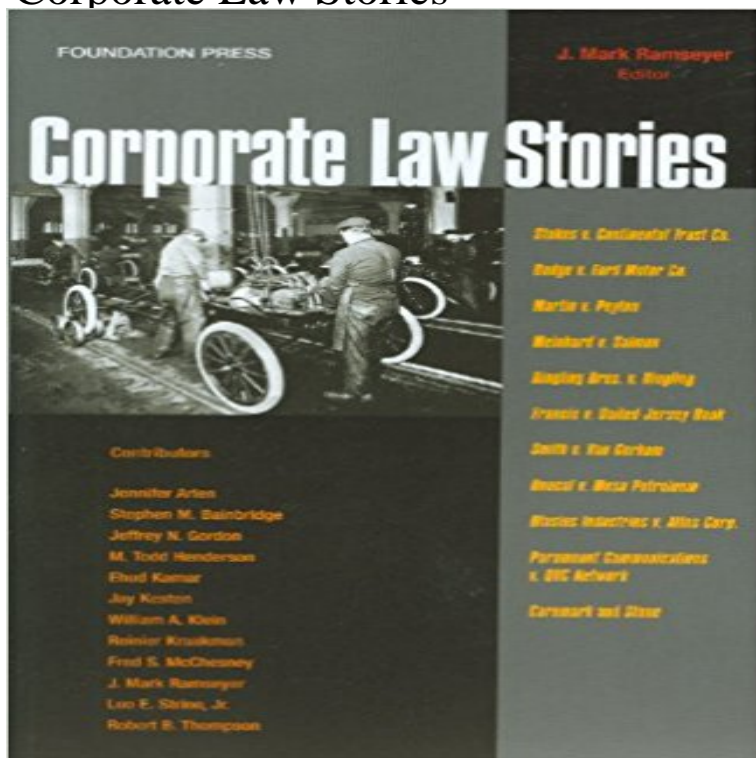


# Corporate Law Stories
