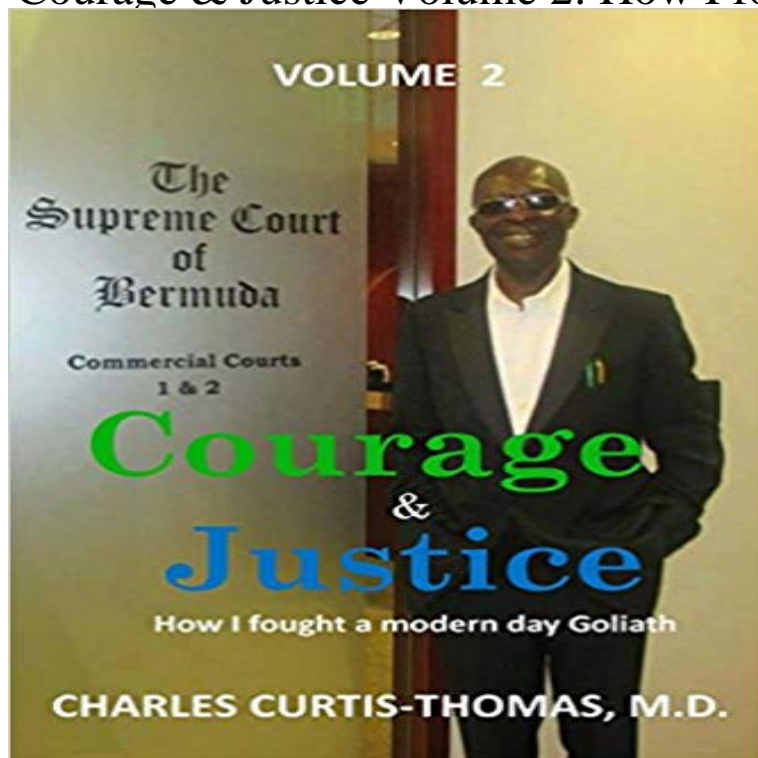


## Courage & Justice Volume 2: How I fought a modern day Goliath
