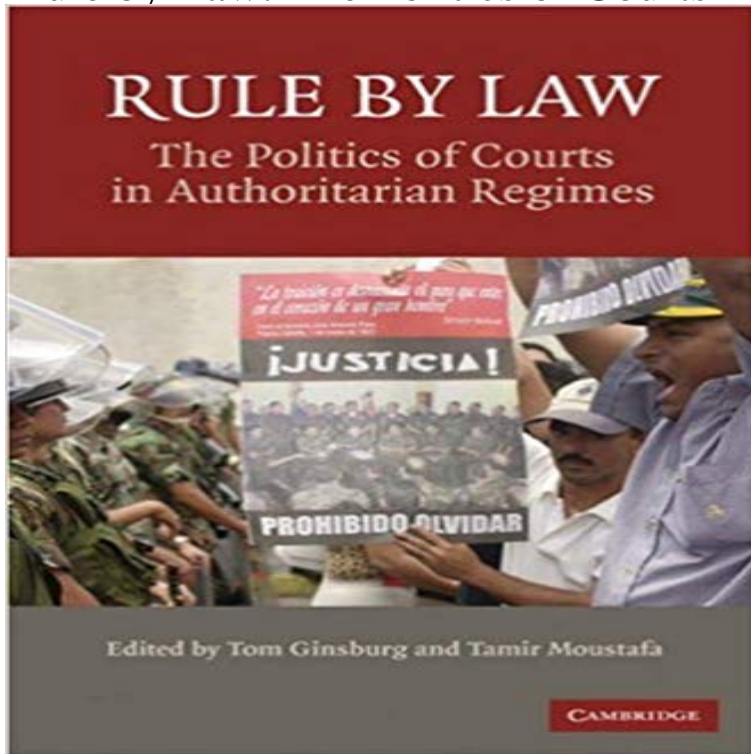


Rule by Law: The Politics of Courts in Authoritarian Regimes
