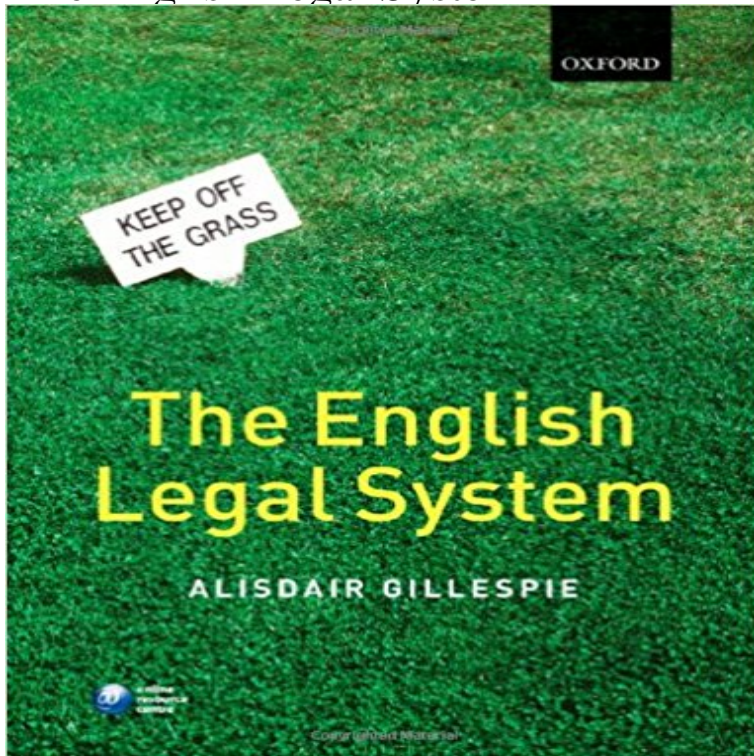


The English Legal System
