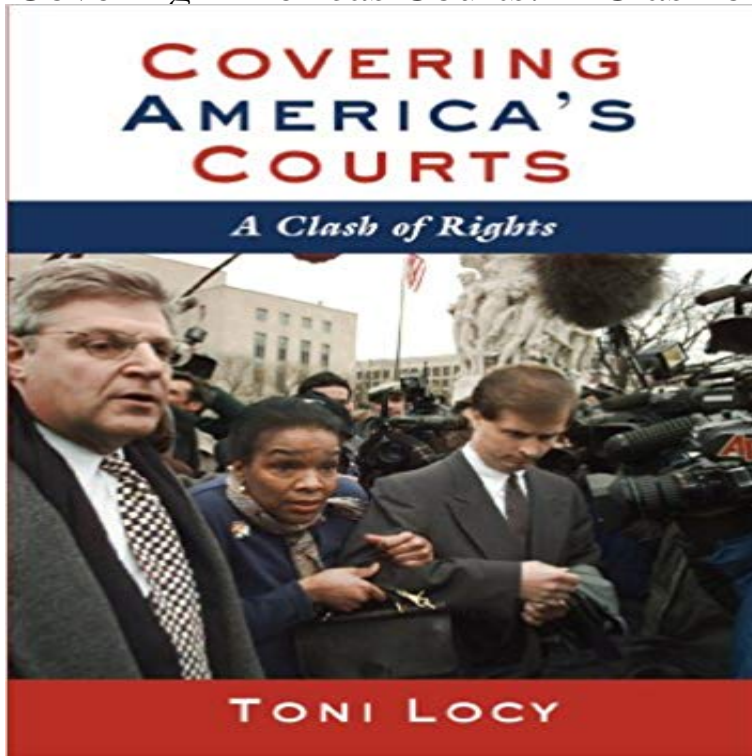


## Covering Americas Courts: A Clash of Rights
