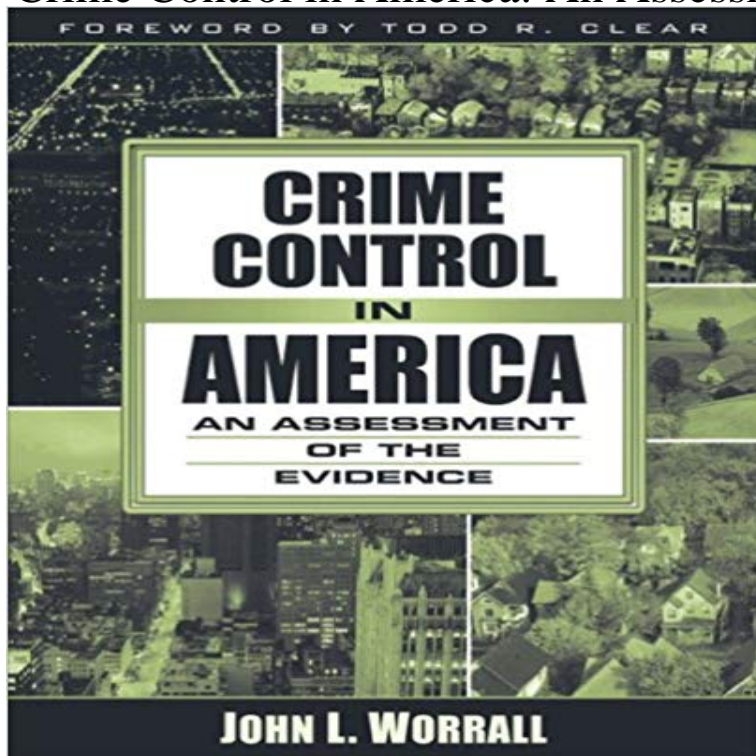


## Crime Control in America: An Assessment of the Evidence
