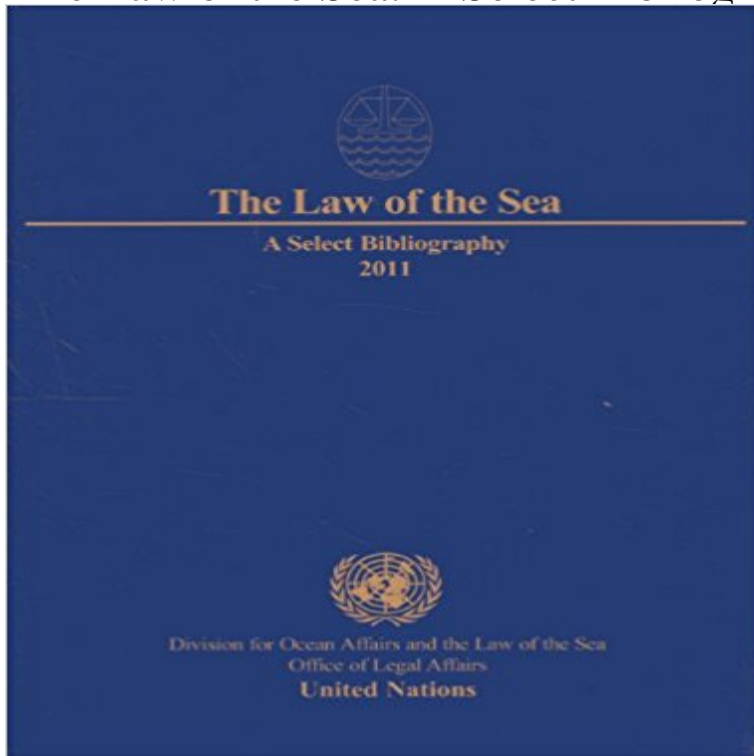


The Law of the Sea: A Select Bibliography 2011
