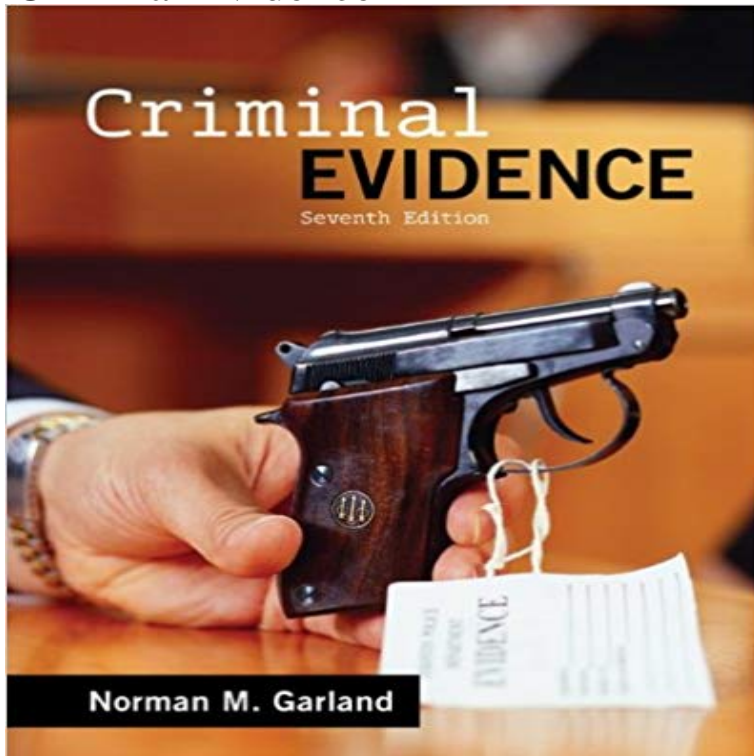


Criminal Evidence
