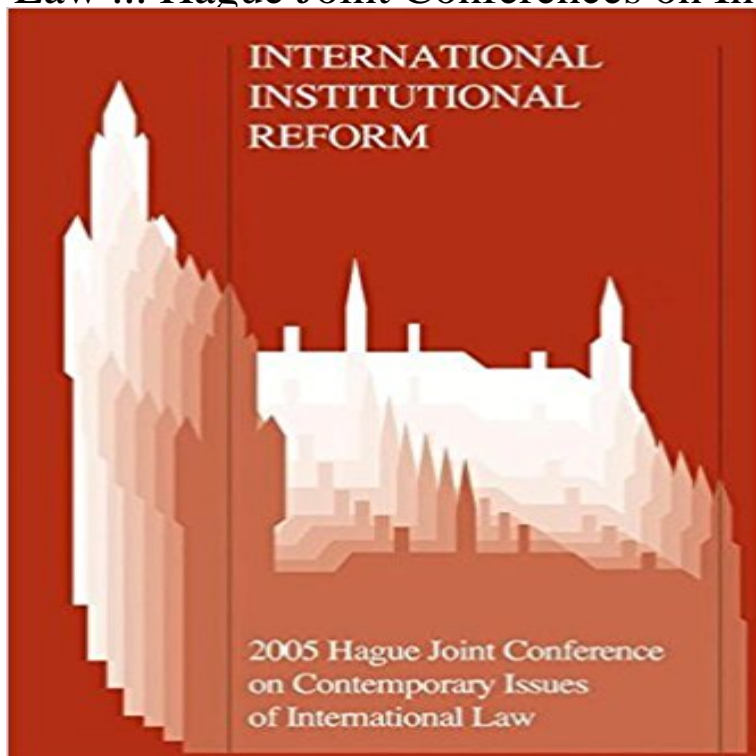

We have taken note with considerable admiration and satisfaction the completion of the manuscript of this book. It contains the proceedings of the highly successful Joint Conference of the American Society of International Law and the Netherlands Society of International Law, entitled Criminal Jurisdiction 100 Years After the 1907 Hague Peace Conference. Our Hague Joint Conferences have increasingly come to serve as the main transatlantic meeting place and forum of debate of international lawyers, including both practitioners and academics. As such they play a useful role in promoting mutual understanding and international co-operation. It proved to be highly relevant to commemorate the Second Hague Peace Conference of 1907 and discuss its contemporary relevance. Whereas international criminal jurisdiction as such was not yet a topic at that time, the 1907 discussions were in respect already highly relevant to it. The Second Hague Peace Conference resulted in a major revision of the 1899 Convention on the Pacific Settlement of International Disputes, a Declaration on obligatory arbitration, a Draft Convention for the Creation of a Court of Arbitral Justice (effectively the first draft of what would become the Statute of the Permanent Court of International Justice), a Convention on the Creation of an International Prize Court (which as a result of a lack of ratifications never came into being) and a series of other conventions, declarations and regulations concerning naval and land warfare.
