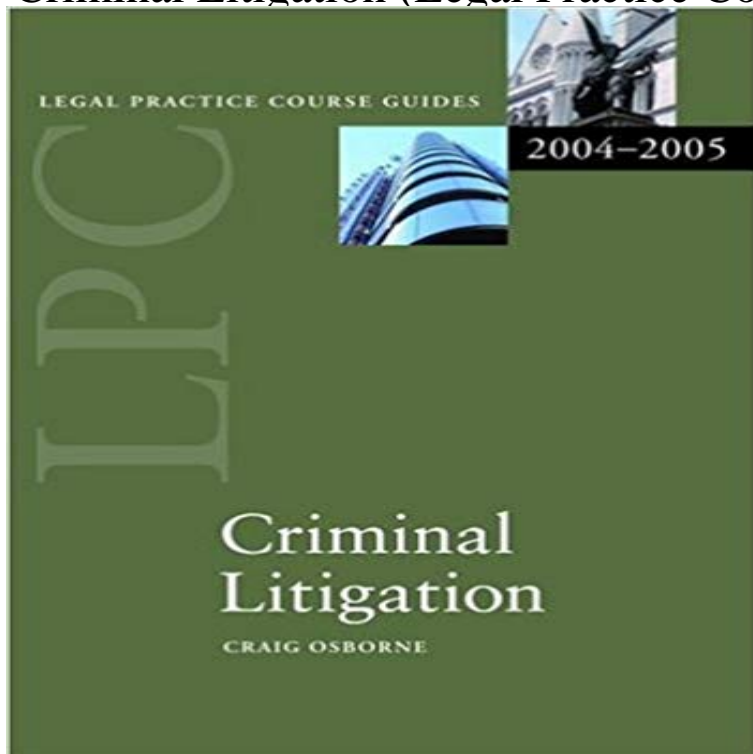


Criminal Litigation (Legal Practice Course Guides)
