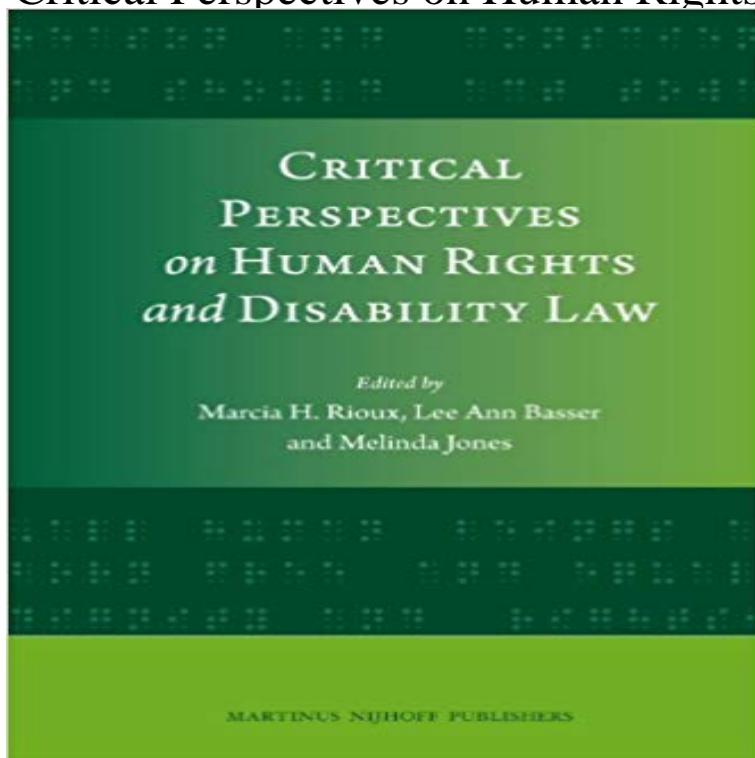


Critical Perspectives on Human Rights and Disability Law
