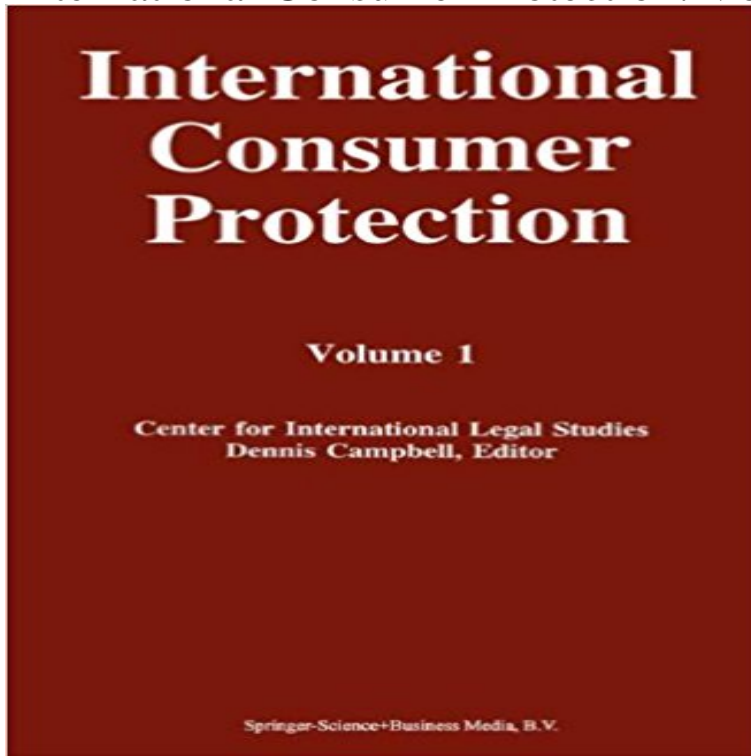


## International Consumer Protection: Volume 1 (Vol 1 & 2)
