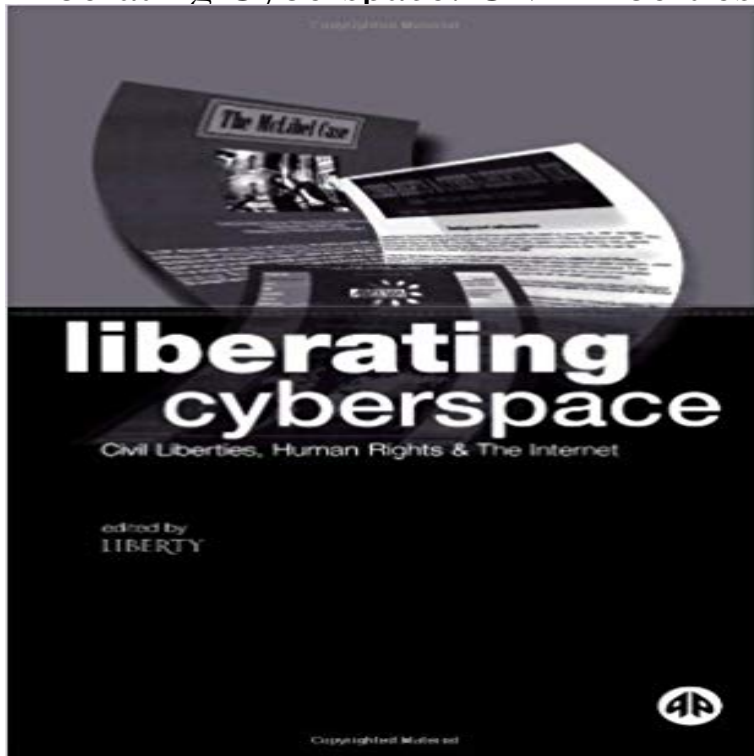


# Liberating Cyberspace: Civil Liberties, Human Rights & the Internet
