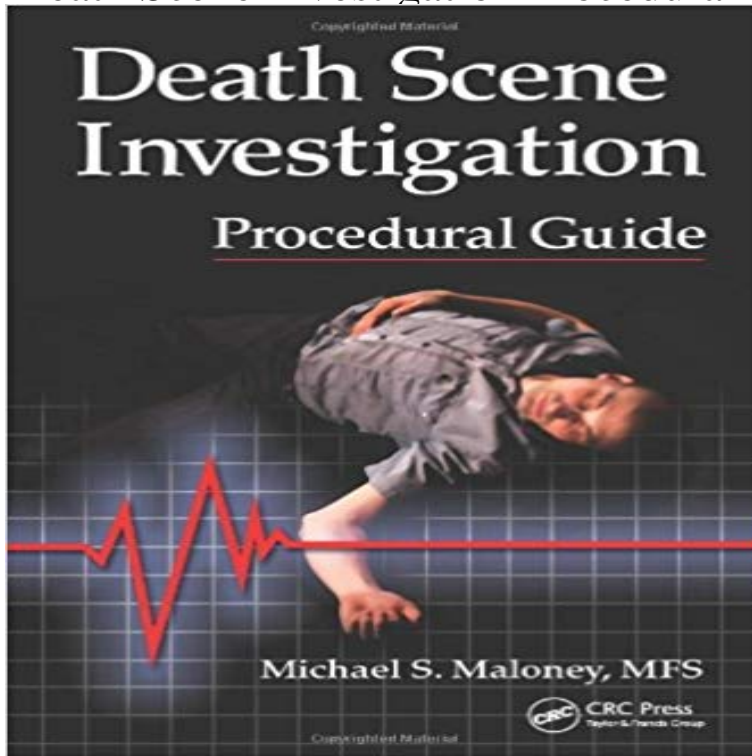

Recovery of human remains from open field, aquatic, and buried sites. This section also discusses estimating the time of death. Wound dynamics and mechanisms of injury. Manners of death include asphyxiation; sharp force, blunt force, and chopping injuries; handgun, rifle, and shotgun wounds; and explosive, thermal, and electrical injuries.
