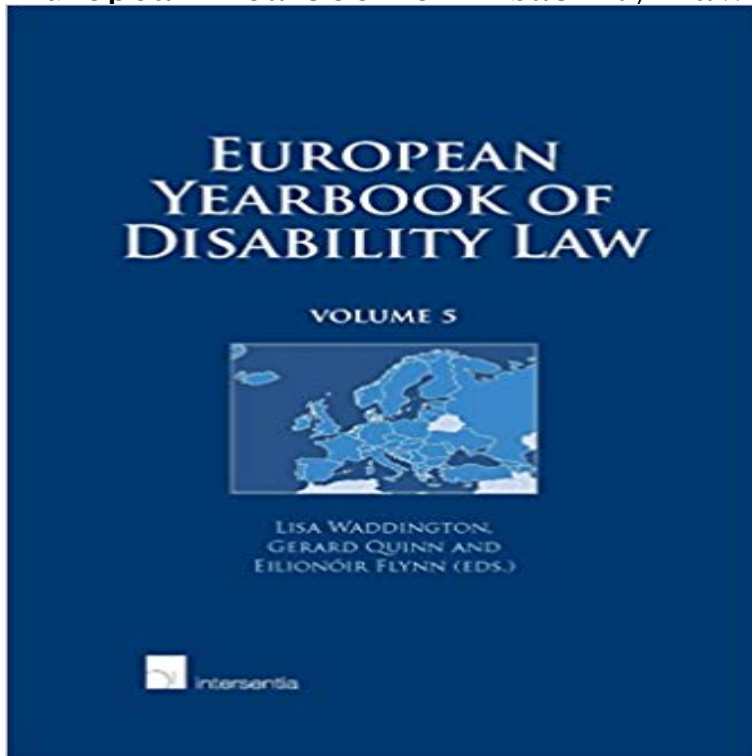


European Yearbook of Disability Law: Volume 5
