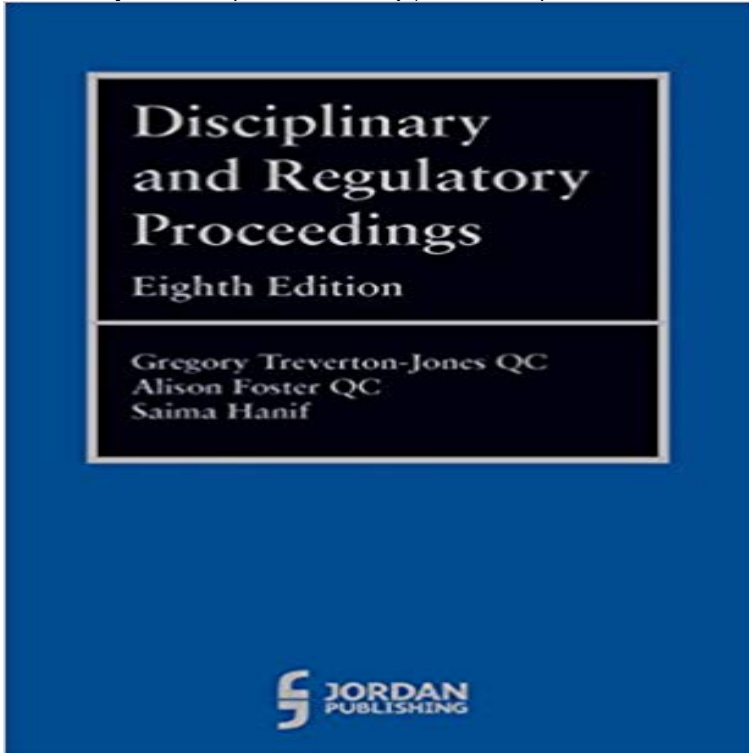


## Disciplinary and Regulatory Proceedings: Eighth Edition
