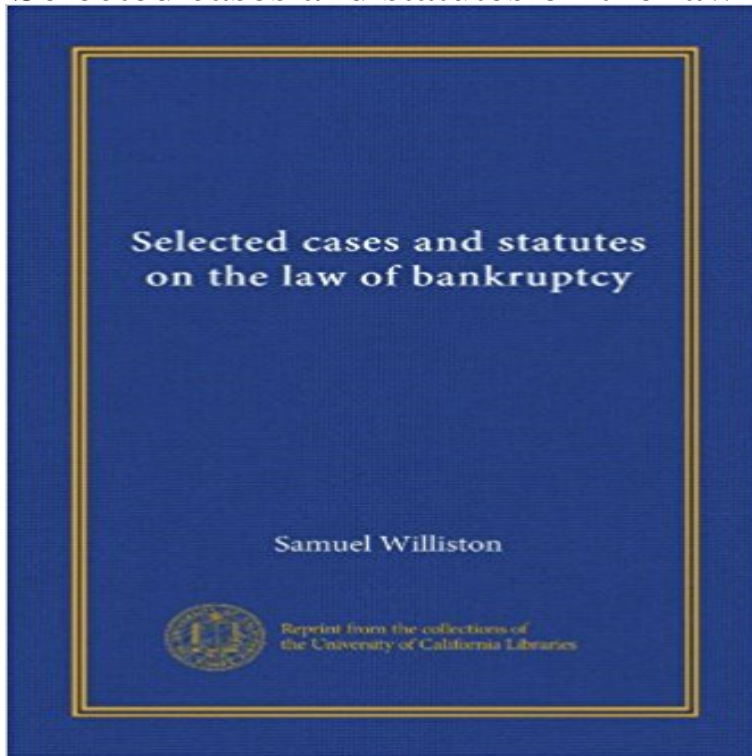


Selected cases and statutes on the law of bankruptcy
