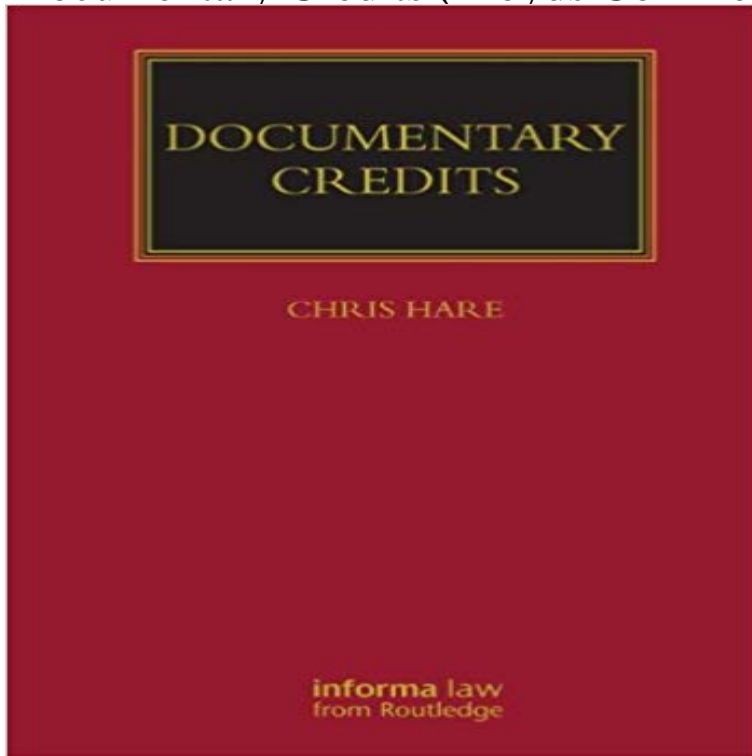


Documentary Credits (Lloyds Commercial Law Library)
