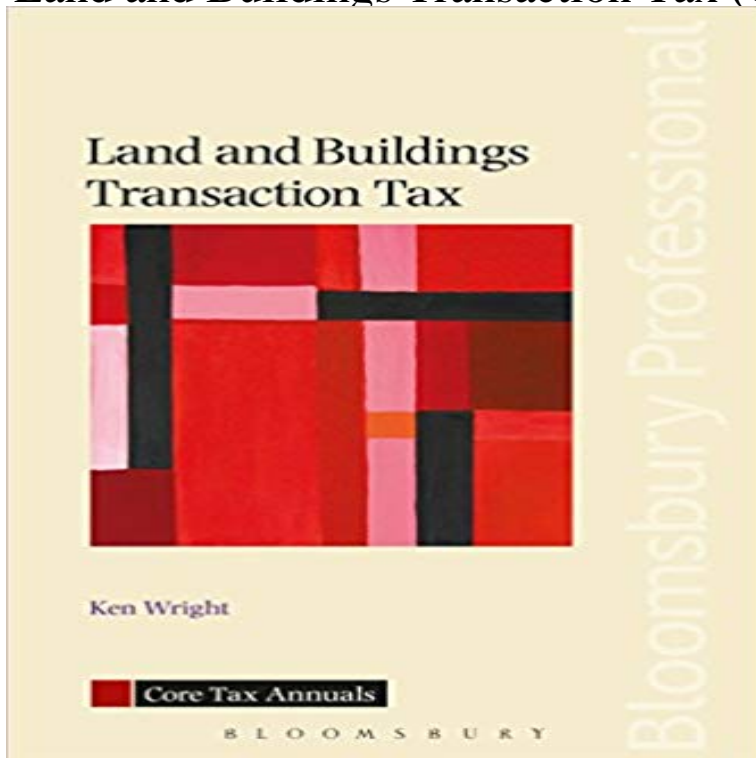


## Land and Buildings Transaction Tax (Core Tax Annuals)
