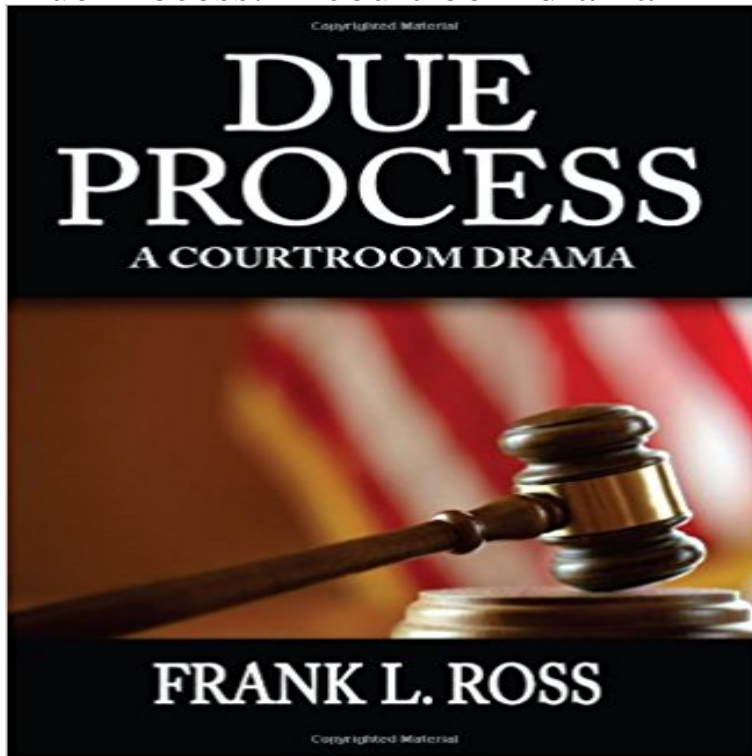


## Due Process: A courtroom drama
