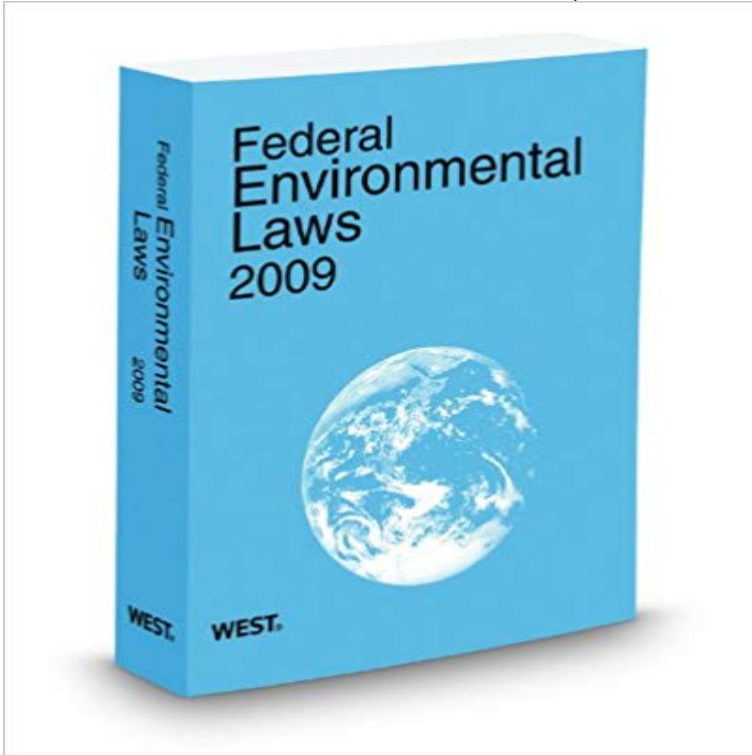


Federal Environmental Laws, 2009 ed.
