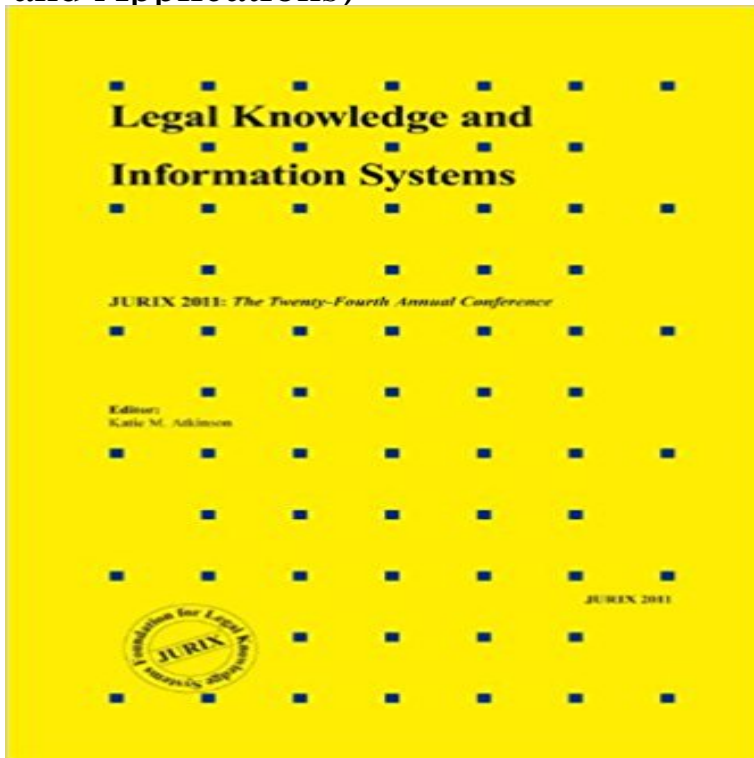

The twenty-fourth edition of the JURIX conference will be held in Vienna, Austria on December 14th-16th at the University of Viennas Centre for Legal Informatics.
