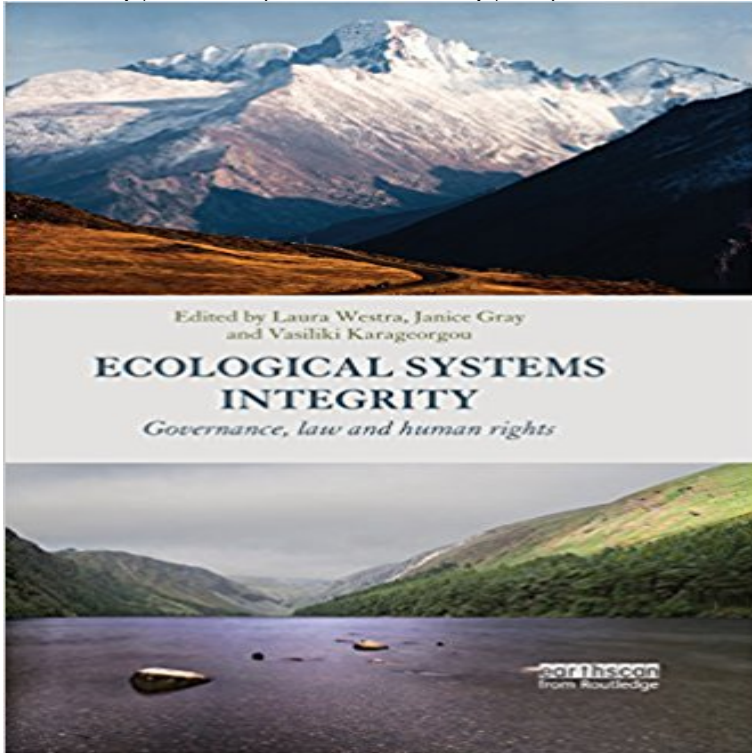


# Ecological Systems Integrity: Governance, law and human rights
