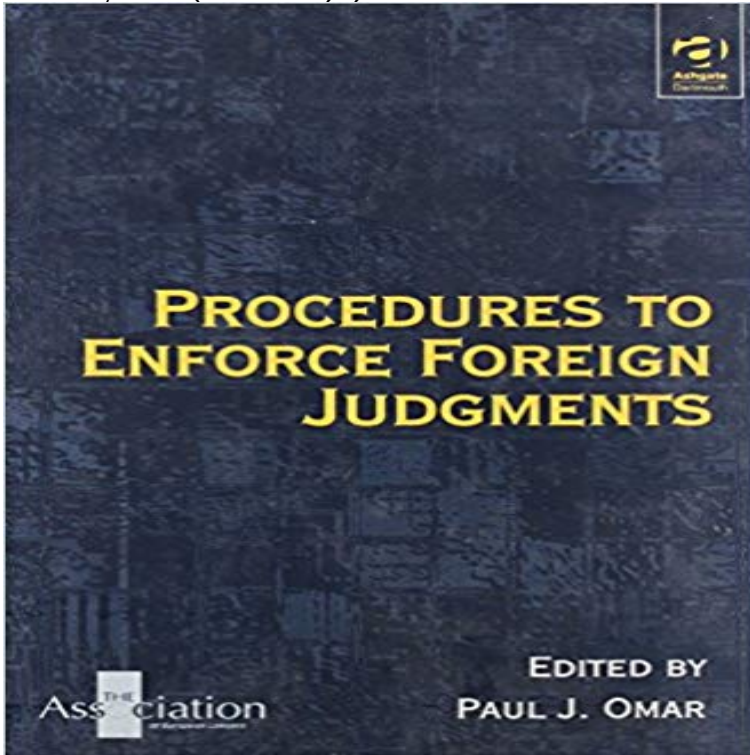


Procedures to Enforce Foreign Judgments (Association of European Lawyers (Series).)
