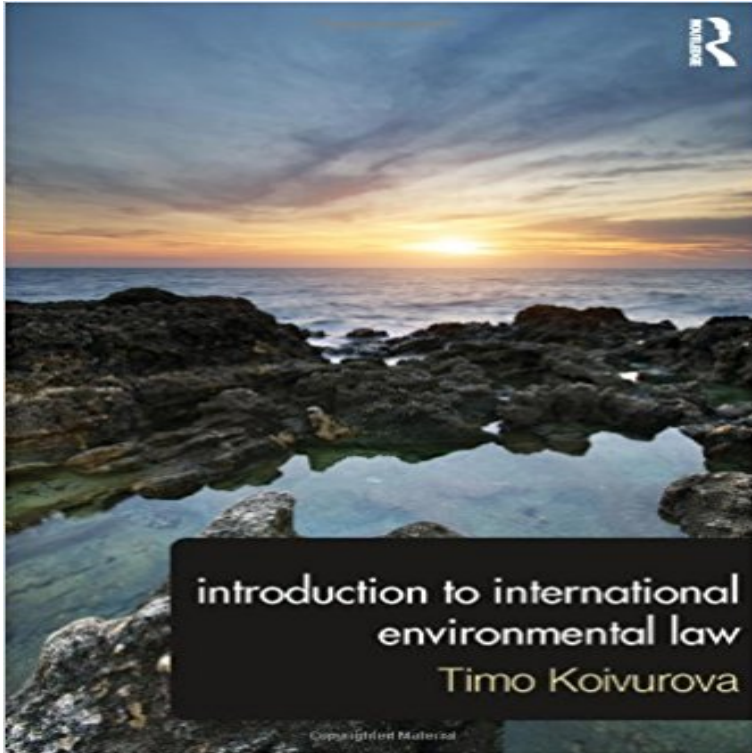


# Introduction to International Environmental Law
