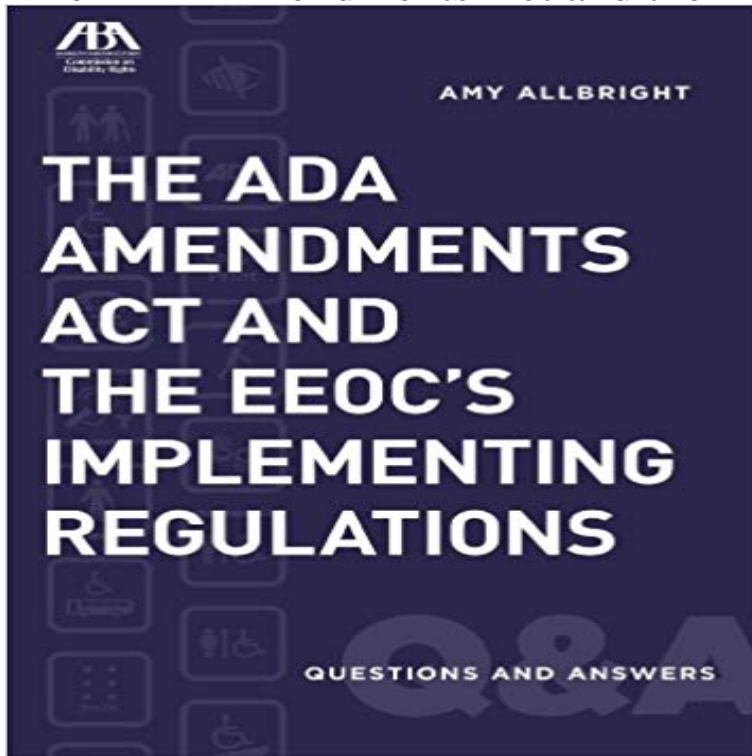


The ADA Amendments Act and the EEOCs Implementing Regulations
