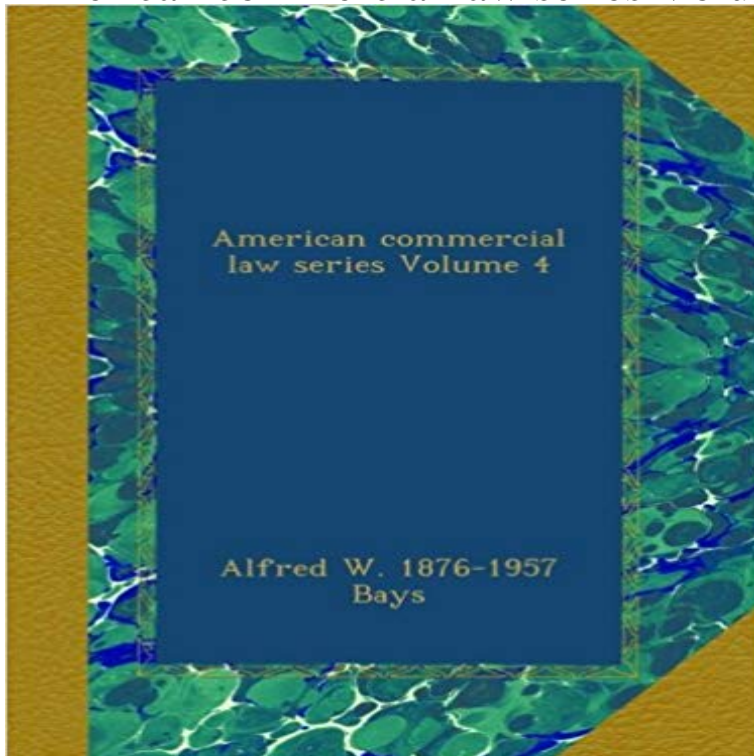


## American commercial law series Volume 4
