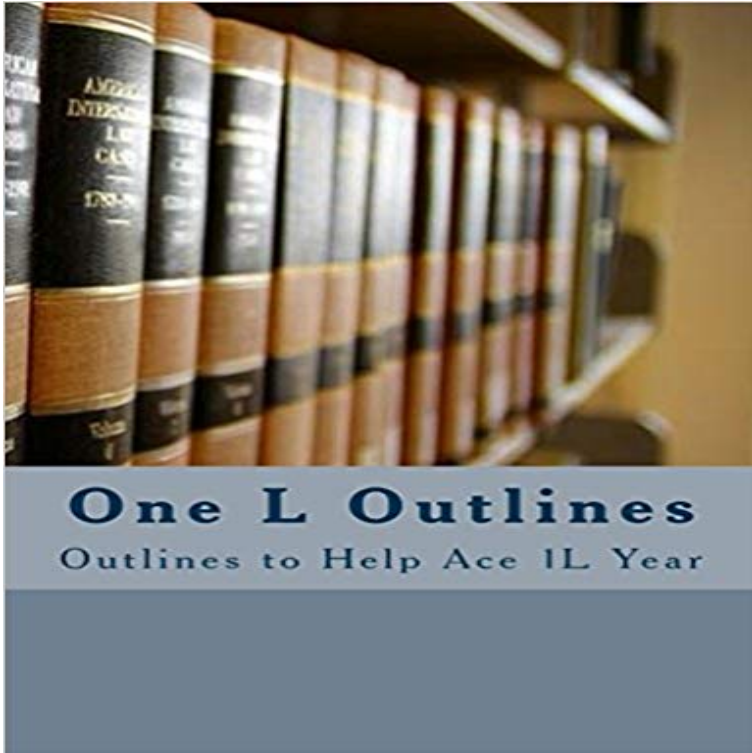


## Law School Outlines: One L Year
