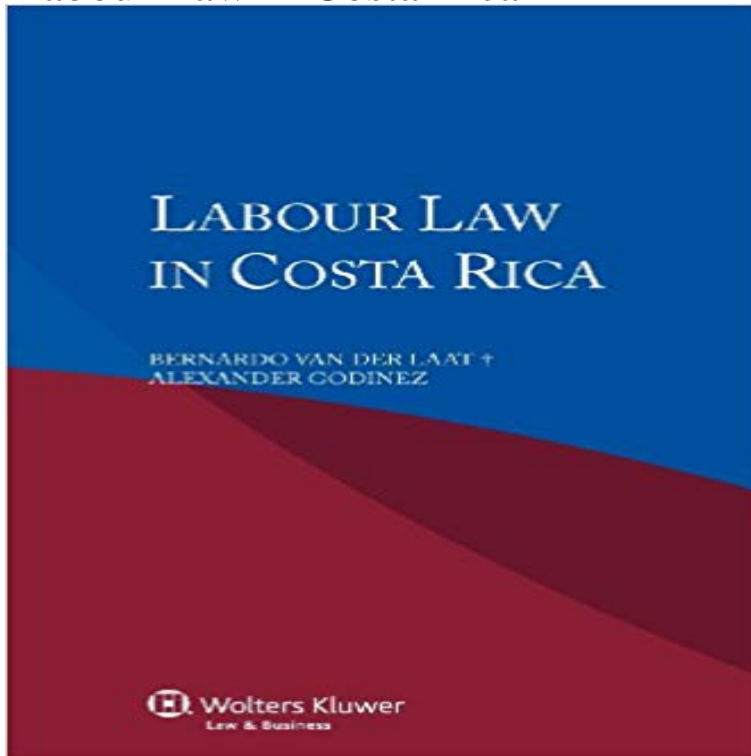


## Labour Law in Costa Rica
