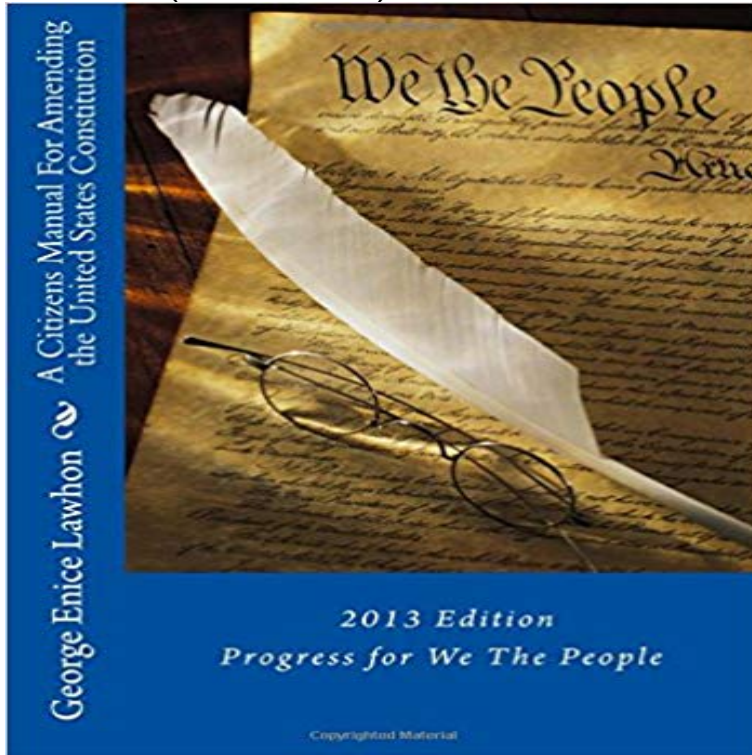


## A Citizens Manual For Amending the United States Constitution: 2013 Edition (Volume 1)

Design Engineering Technical Writing Quality Assurance/QC System Design Quality Audits/Surveys Acceptance Documentation Package Preparation Later at the Kennedy Space Center I wrote maintenance manuals for the government (Corps of Engineers), and then, working as a Technical Writer for Grumman Aerospace on the Apollo Moon Project, I wrote procedures for astronauts for in-flight orbital operations on the LEM (Lunar Excursion Module). I will add that along the way I attended college, where, during a course in American Government, the Professor reignited a long smoldering fire that began in my high school Civics class.
