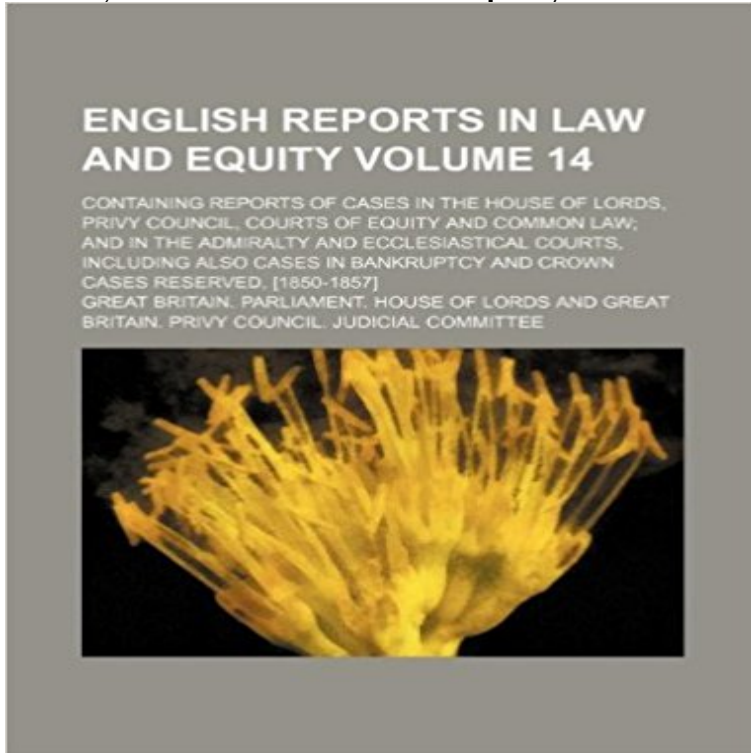

Not illustrated. 1853 Excerpt: ... unto Messrs. Rothschild & Sons, of London, or his or their assigns, he or they paying freight at the rate of one and three eighths per cent. All the boxes were brought across the Isthmus of Panama, and were shipped at Chagres for Southampton, where they arrived in due course; but in the course of their transmission to London, by the railway, one of the boxes was stolen, without violence. The jury found that the defendants were guilty of negligence in the conveyance of them to London, and that this negligence caused the loss. *De Rothschild v. The Eoyal Mail Steam Packet Company*.
