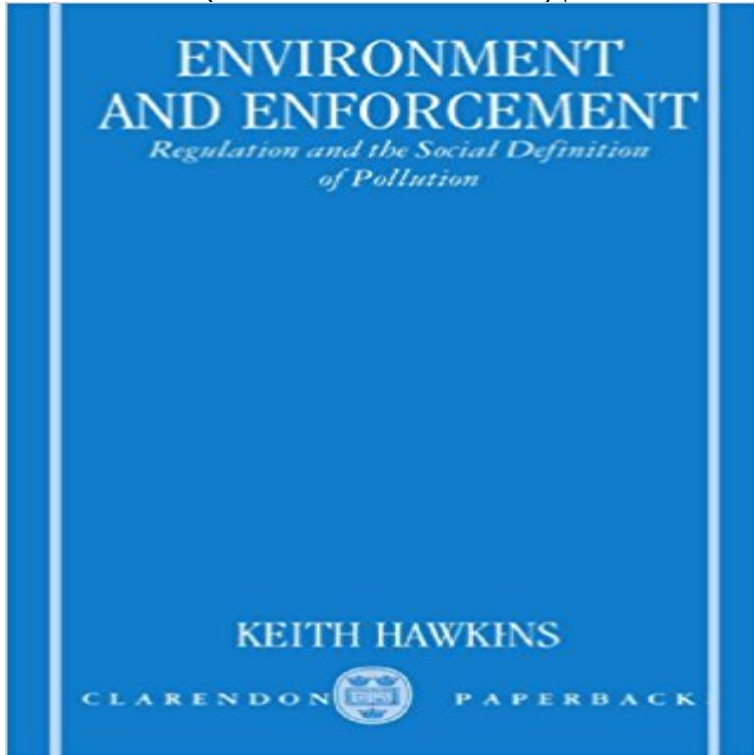


# Environment and Enforcement: Regulation and the Social Definition of Pollution (Oxford Socio-Legal Studies)
