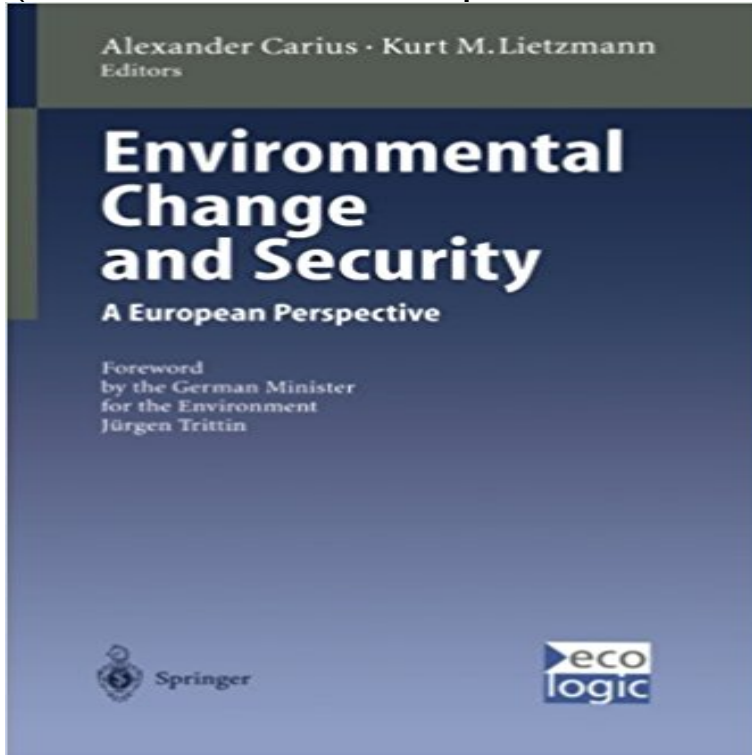


Environmental Change and Security: A European Perspective (International and European Environmental Policy Series)
