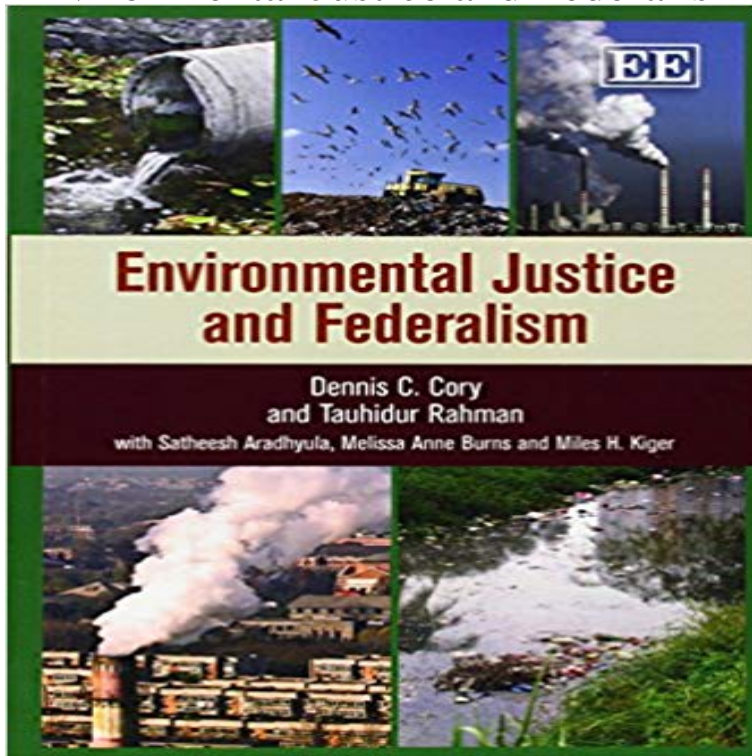


Environmental Justice and Federalism
