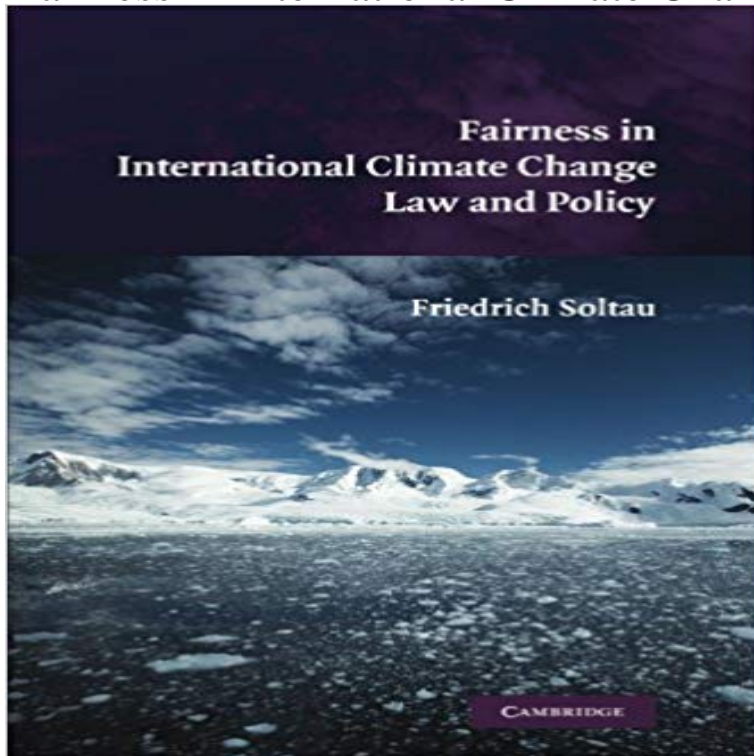


Fairness in International Climate Change Law and Policy
