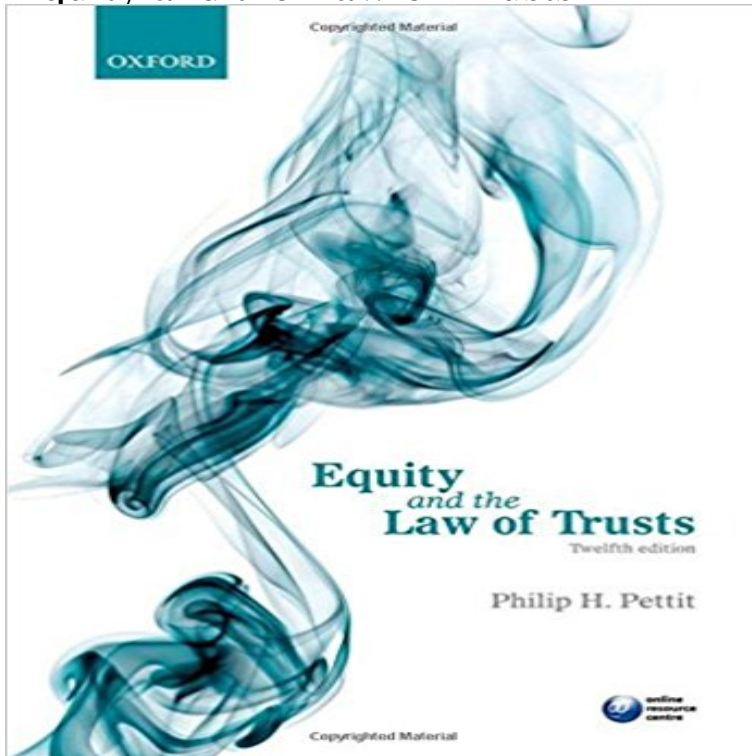


# Equity and the Law of Trusts
