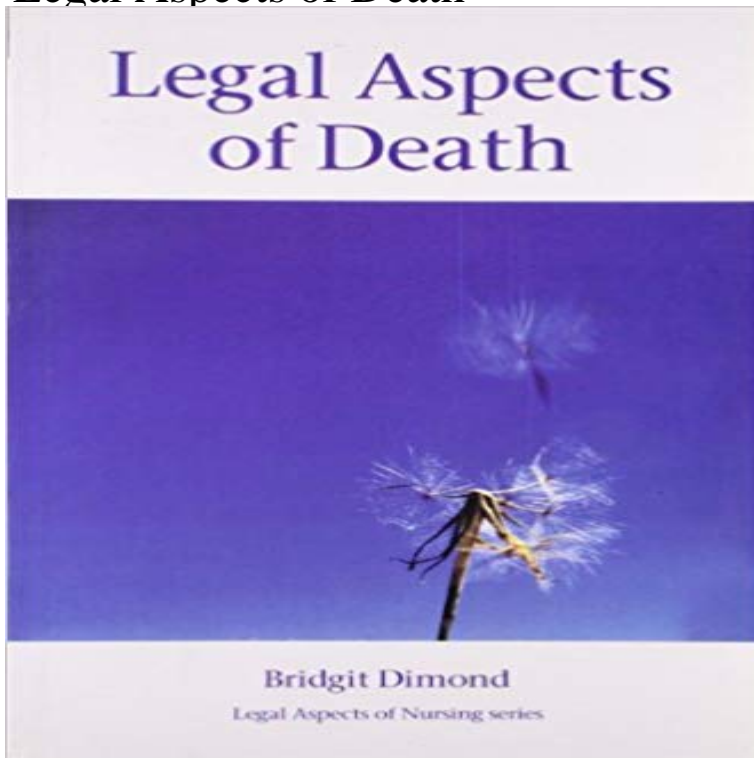


Legal Aspects of Death
