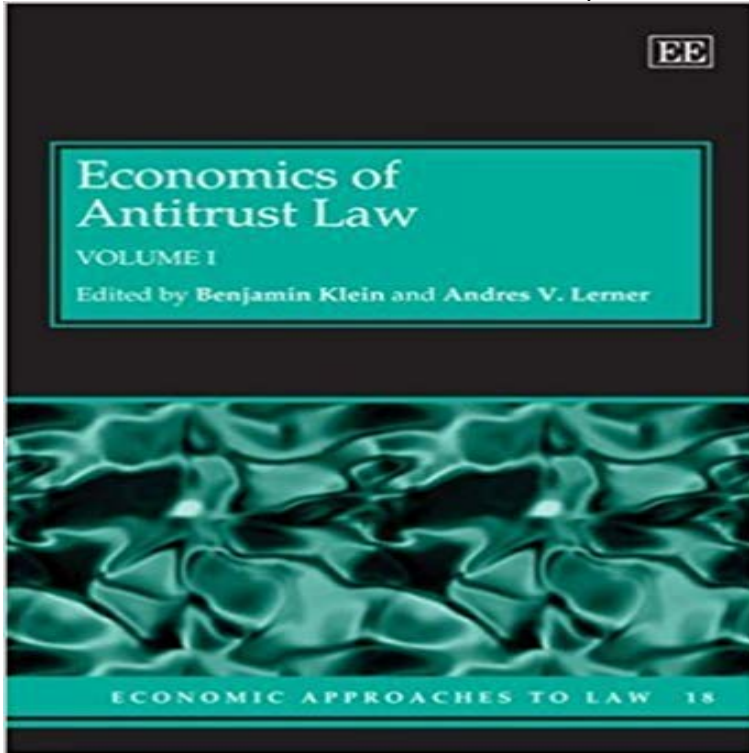


Economics Of Antitrust Law (Economic Approaches to Law)
