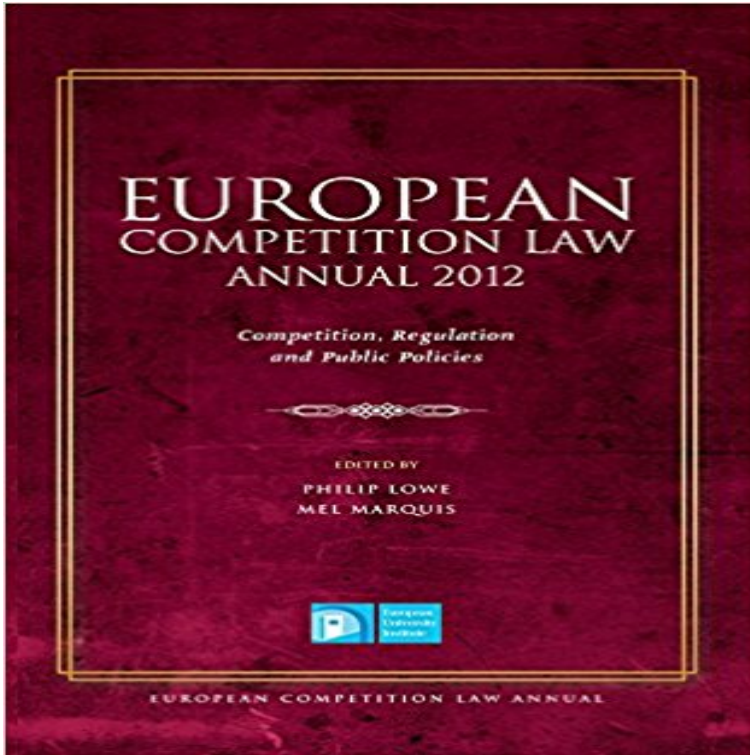


# European Competition Law Annual 2012: Competition, Regulation and Public Policies

Comparative views and the views of judges from different jurisdictions are provided, and techniques for mediating among different policy objectives and frameworks are discussed.
