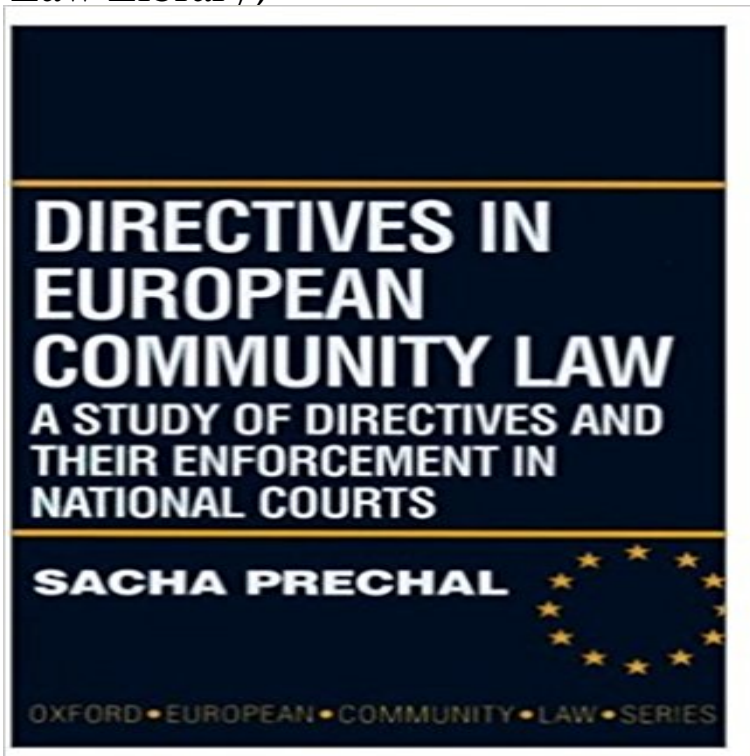


# Directives in European Community Law: A Study of Directives and Their Enforcement in National Courts (Oxford European Community Law Library)
