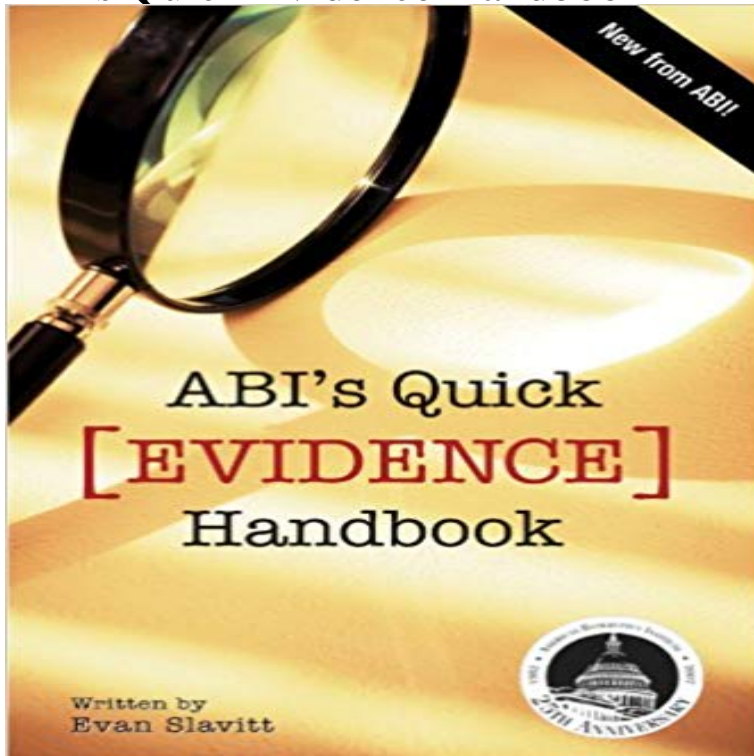


ABIs Quick Evidence Handbook
