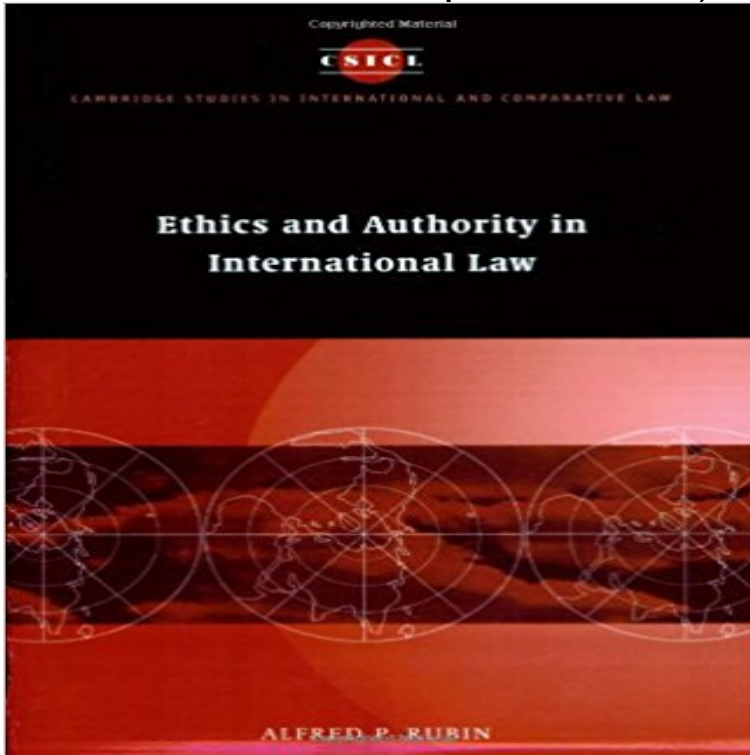


Ethics and Authority in International Law (Cambridge Studies in International and Comparative Law)
