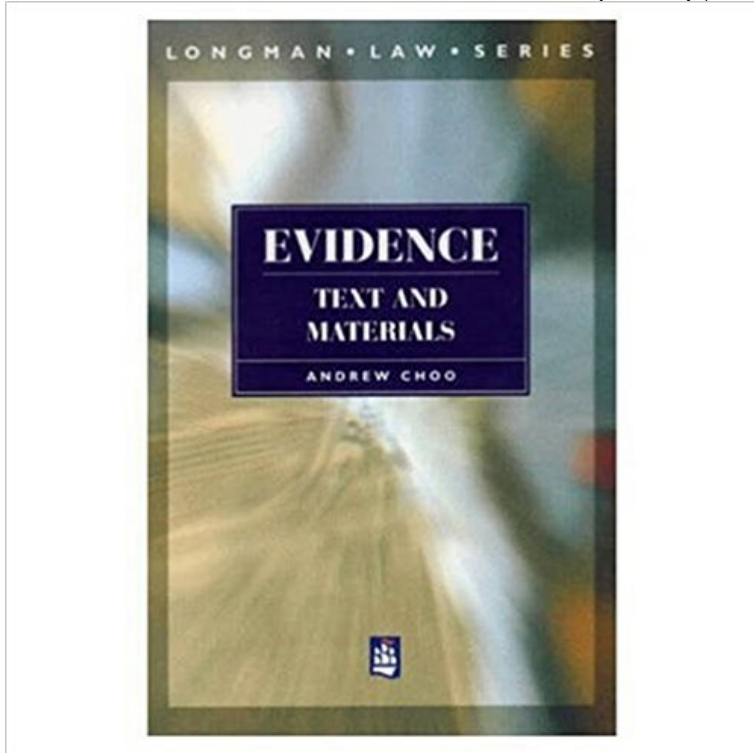


## Evidence: Text and Materials (Longman Law Series)
