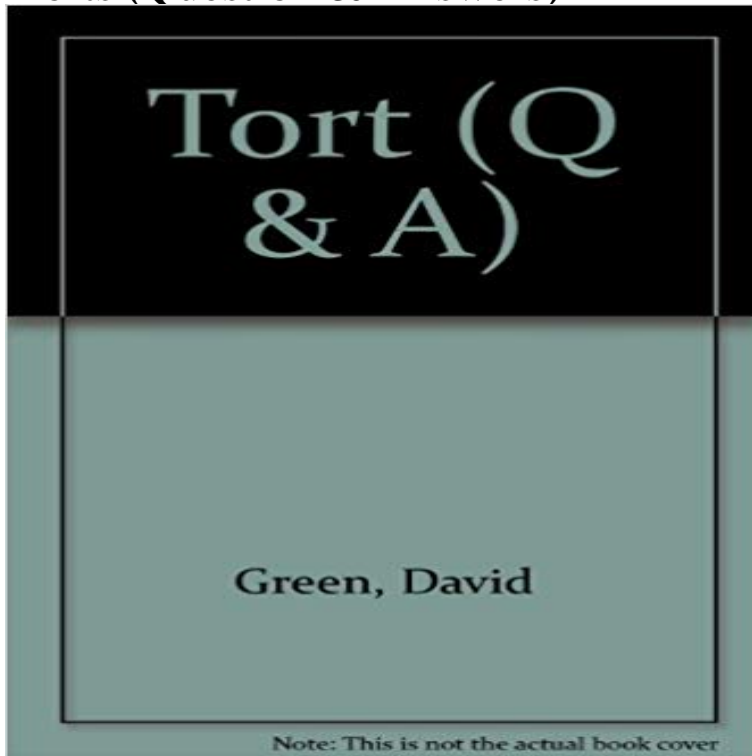


Torts (Question & Answers)
