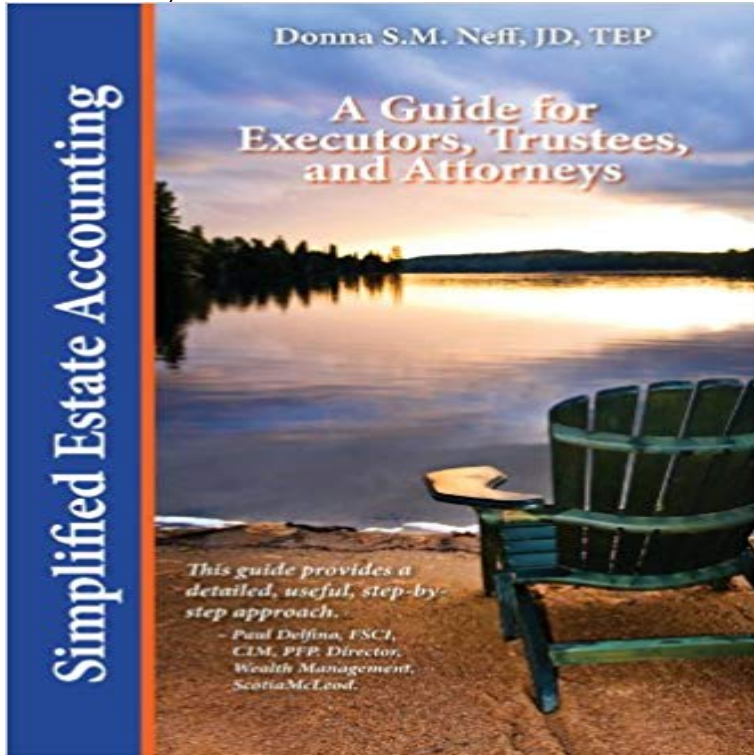


# Simplified Estate Accounting: A Guide for Executors, Trustees, and Attorneys
