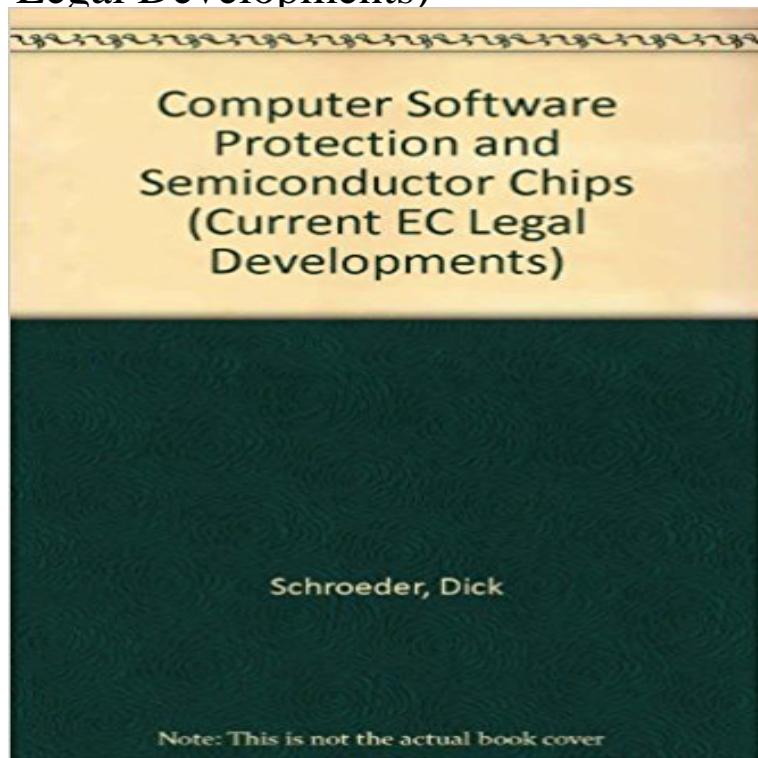


Computer Software Protection and Semiconductor Chips (Current EC Legal Developments)
