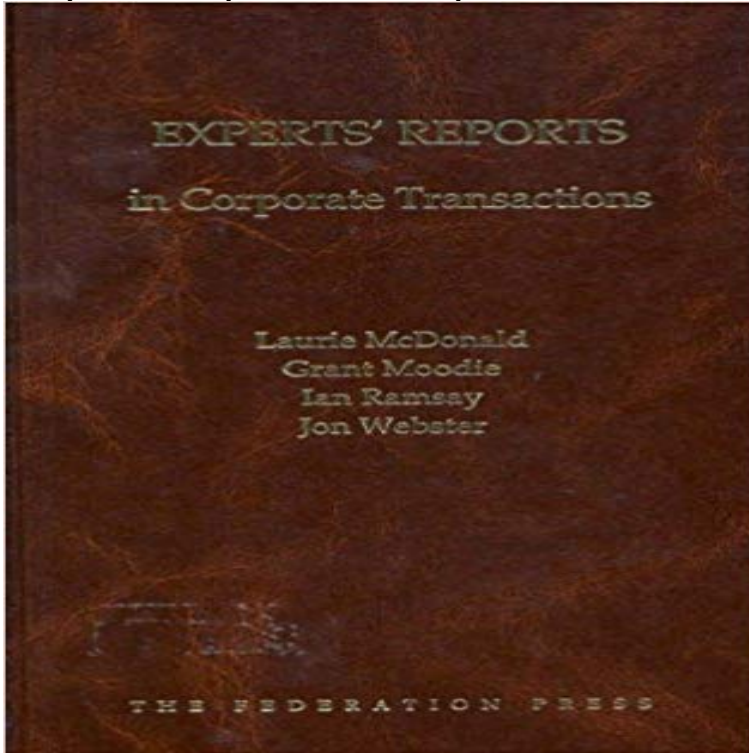


Experts Reports in Corporate Transactions:
