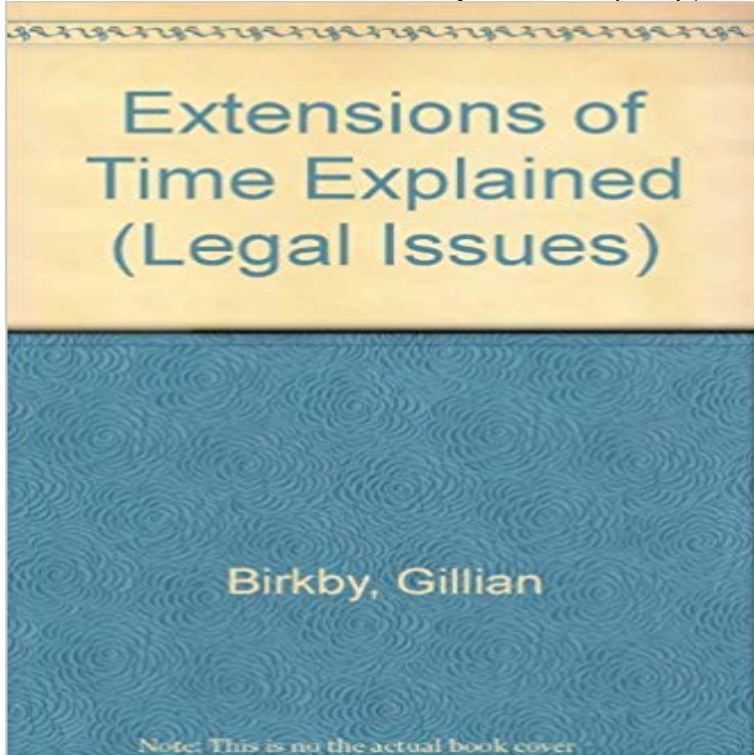


Extensions of Time Explained (Legal Issues)
