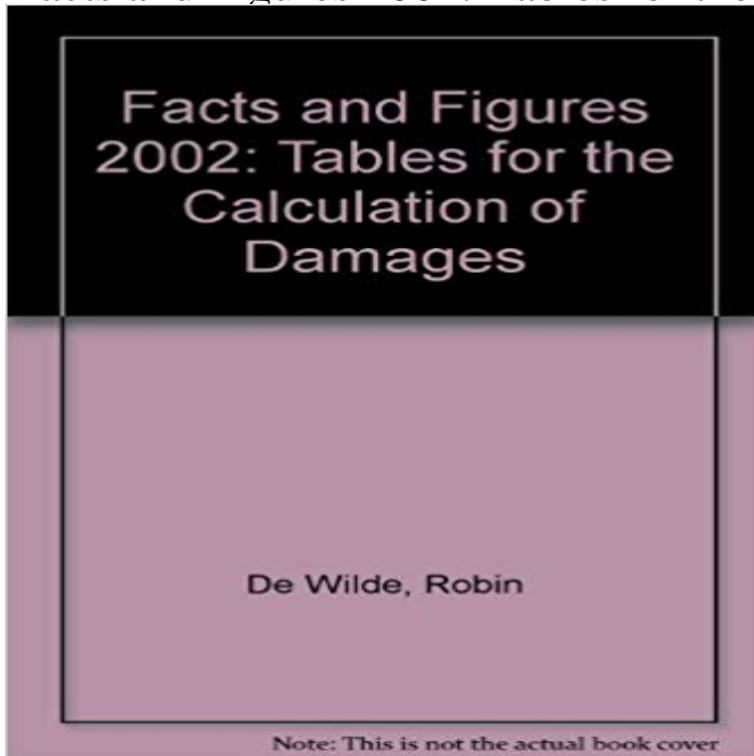


## Facts and Figures 2002: Tables for the Calculation of Damages
