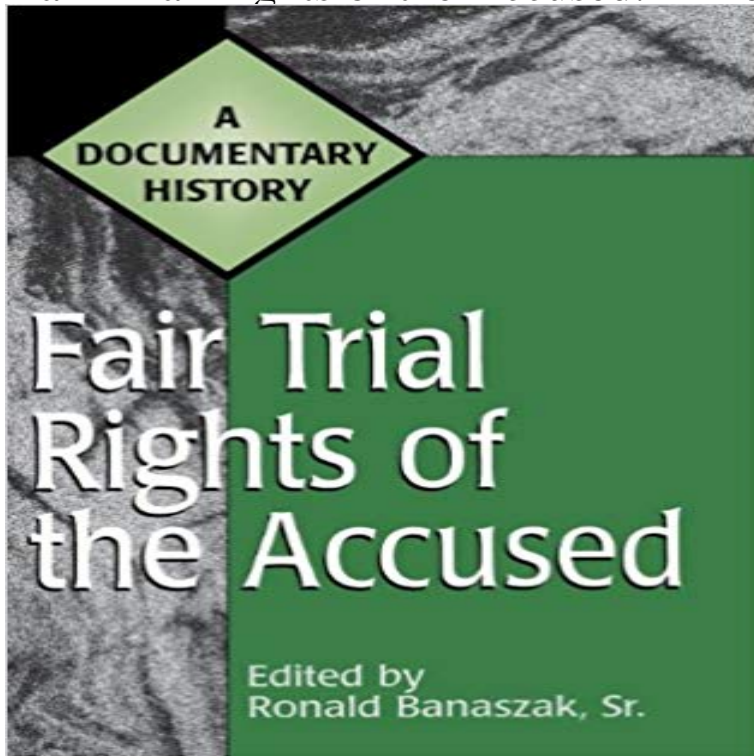


Fair Trial Rights of the Accused: A Documentary History
